(MECT)" held on 03rd February 2018 , it was resolved to amend the Trust Deed by adding New Clauses, alteration and New Board of Trustees. AND WHEREAS the Board of Trustees in the said meeting unanimously decided to make the said amendments by way of modification and has authorized to execute and register the necessary Deed of Modification and to do all acts , deeds and things for the completion of the registration and the authorization subsists and hence this Deed. NOW THIS INDULTURE WITNESSETH AS FOLLOWS: 3. In order to effectuate the said object of creating and establishing a public charitable Trust, the settler has delivered to and made over to the Trustees a sum of Rs.1000/- (Rupees one thousand only) with intent to part with all his right, title and interest claim therein and vest the same in the Trustees to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represents the Trust estate together with all additions and accretions thereto and all accumulated -----Mohammed Hameed signed 7-----income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the Trust (hereinafter referred to as "THE TRUST FUND") for the charitable objects and purposes and uses hereinafter expressed with the powers and on the terms and conditions herein contained of and concerning the same. 4. The name of the Trust shall be 'MALAPPURAM EX-SERVICES S LEAGUE CHARITABLE TRUST' (MECT) and the office of the trust shall be situated at Vimukta Bhada Bhavan, Jubilee Road, Malappuram which may be shifted from time to time such other places as the Trustees may deem fit and proper at their discretion.5.The objects of the Trust shall be to undertake such welfare measures as given below primarily for the amelioration of the Ex-Services men (ESM) fraternity of Malappuram

District. (i) To establish, promote, set-up, run, maintain, assist, finance support and/or aid to or help in the setting up and/or maintaining and/or running schools and other institutions orphanages, widow homes, lunatic asylums, poor houses or other establishments for relief and/or help to the poor, old and infirm people and/or destitutes. (ii) To give, provide and/or render help and assistance in cash or kind to poor and/or destitute people windows etc of ESM. (iii) To give, provide and/or render help and assistance to and/or implement any scheme for providing livelihood and upliftment of the poor. (viii) To open, found, establish, promote, set-up, run, maintain, assist, finance support and/or running schools, colleges, lecture halls and other establishments or institutions for advancement of education and of knowledge in Arts, Science, Literature, Humanities and all other useful subjects in all their manifestations. (ix) To open, found, establish, promote, set up, run, maintain, assist, finance support and/or aid or help in the setting up and and/or maintaining and/or running hospitals, boarding houses, libraries, reading rooms, gymnasium and other training and vocational institutes. (x) To promote advance and encourage and/or aid in helping, promoting advancing and encouraging primary, secondary and higher education including Technical and medical education also physical training, training of handicrafts, fine arts and other useful arts, crafts among the public including the establishment and maintenance of Shiipa-shikshalayas, Kala Kendras and other welfare centres. (xii) To meet travelling, boarding and lodging expenses for students going abroad for higher commercial and technical education. If any or more of the objects specified in clause (5) of these presents are held not to be objects of a public charitable nature, the trustees shall not carry out such object or objects as if the same are incorporated in these present but the validity of the trust created by these presents as as Trust for public charitable purposes shall not be affected in any manner.7 The financial year of the trust shall end on 31st march, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper. The first financial year of the trust shall close on 31st March 2015.8. The Object/Activities of Trust shall be regularly maintained and every year, the Accounts shall be closed by 31st March and the same shall be audited by a qualified Chartered Accountant. -----Mohammed Hameed signed 10-----9. The trustees may accept any donation or contribution in cash or kind from person, firm, "Company", corporation, associations, institutions or trust (including the settlor or the trustees or any of them) for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. The trustees may also take over the management of any charitable or public institutions on such terms as they thing for and may manage such institutions.10. Without affecting the generality of powers and functions of the trust to manage and administer the trust, the Board of trustees shall have the following functions: (i) To borrow if needed be against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees including the chairman and managing trust to execute such documents, deeds, papers, etc., as may be necessary in connection herewith. (ii) To arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the Trustees by the chairman and the Managing Trustee and any one of the Trustees to be nominated in this behalf by the Board of Trustee and to make the same effective and bindings as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees. (iii) To appoint or make provisions for the appointment of a sub-committee of trustees and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the Trustees may prescribe. (iv) To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject to such terms and conditions, rules and

made which are directly or indirectly for the benefit of any person referred to in sub-sec(3) of Sec. 13 of Income Tax Act,

1961 or any subsequent amendment as may be made from time to time. 13. If the income from the trust property in a

particular year is not fully utilized the unexpended income subject to the applicable provisions of the Income Tax Act, 1961

shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of

the object of the Trust. 14. The trustees shall be at liberty to sell such portions of the movable or immovable properties

forming part of the Trust Estate either by public auction or by private contract at such price or prices and in such terms

and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind

The Trustees may establish its office at such places and change such places from time to time they may think fit.20 The Trustees may demise the immovable property and properties for the time being and from time to time belonging to the Trust either from year to year for any fixed term or for any terms of years or on monthly tenancies at such rent and subject to such covenants and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.21. The trustees shall have full power to compromise or compound all act suits and other proceedings and settle difference and disputes touching the Trust Estate and /or the Trust properties and to refer and such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or the Trust properties and to do all other acts and things fully and effectually without being liable to answerable for any bonafide loss occasioned thereby.22 The Trustees may from time to time frame schemes and rules and regulations to carry out the objects of the trust and for managing the affairs of the trust and otherwise for giving effect to the objects and purposes of the Trust and to vary the same from time to time as the trustees may in their discretion deem fit and proper.23The receipts granted by the trustees or any one or more of them for any moneys, stocks, funds, shares, securities or investments paid, delivered or transferred to them in exercise of the trust or powers hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.24. The trustees shall entitled at their discretion from time to time to start, discontinue, abolish and restart and charity or charitable institution, to impose any condition or conditions -----Mohammed Hameed signed14-----to any subscription or donation made by them and to earmark any portion of the Trust property or Income for any particular object or objects.25. The trustees may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred by them in or about the execution of the Trust or any of their duties under these presents including travelling expenses, but will not be entitled to any remuneration. 26. The number of trustees shall be not less than two and not more than nine.27.Any trustee may retire at any time without assigning any reason and without being responsible for any occasioned by such retirement such vacancy/vacancies of Trustees will be filled only when office bearers of KSESL Malappuram District are duly elected.28The surviving or continuing trustees may not withstanding any vacancy in their board act as trustees PROVIDED HOWEVER that if the number of trustees shall fall below two the minimum fixed by their presents, the trustee shall not, except for the purpose of filling any vacancy act so long as the number is below the said minimum.29 Five including Chairman and the Managing trustee at a meeting shall form a

quorum for any meeting of the Trustees.30.The elected President of KESL Malappuram District Committee shall automatically be the Chairman and Managing Trustee. In case he voluntarily retires or is removed from the Trusteeship in accordance with clause 42 and he continues to hold the office of President of KESL Malappuram District Committee shall become the Interi Chairman and the Managing Trustee until a newly elected president KESL District Committee assumes the office.31All proceedings and questions and matters arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the Chairman and the Managing Trustee shall have a second or casting vote PROVIDED HOWEVER that notwithstanding anything herein stated no question dealing with the disposal of the Corpus of any of the Trust ----- Mohammed Hameed signed 15-----properties and/ or investment out of the Trust corpus shall be decided except with the consent of the Chairman and the Managing Trustee of the Trust.32In case of difference of opinion between the trustees, the opinion of the majority shall prevail and if the Trustees are equally divided in any matter, the Chairman and the Managing Trustee shall have a casting vote.33. All meetings of the Trust shall be held at such place and at such time as the Chairman and the Managing Trustee of the Trust shall decide from time to time. At least two such meetings shall be held in a calendar year.36A trustee who is unable to present at a meeting of the Trustees send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.37 The Minutes of the proceedings of every meeting of the Trustees shall be entered in a book to be kept for that purposes and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence the business and other matters transacted at such meeting.38.No person being,(i) an un-discharged insolvent, or (ii) convicted of an offence involving moral turpitude or (iii) of unsound mind, or (iv) a minor shall be eligible to be a trustee.39.A person shall cease to be Trustee in any of the following events-----Mohammed Hameed signed 16----- (a) If he dies or (b) If he becomes bankrupt or (c) If he becomes insane or otherwise become incapable to act or (d) If he resigns or otherwise ceases his office of KESL Malappuram 40. On a new or a additional trustee being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment, the trust property shall automatically vest in him along with the other trustees for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other deed of writing. 41. The Board of trustees shall be entitled to sue in the name of the Trust and may similarly be sued in the name of the Trust. 42. The Board of Trustees may, by a unanimous vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, permanent or otherwise, from office after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust estate or trust affairs



and after arriving at a definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee or these presents was desirable keeping to the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his conduct and /or the changes leveled against him for his removal. And the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere. 43. All trust properties movable or immovable shall on dissolution of the trust vest with the Government. The trust shall not be dissolved so long as Kerala State Ex-Services League, Malappuram District is in existence. ----- Mohammed Hameed signed 17 ----- 44. In the event of Dissolution/Winding of the Trust the Assets remaining on the date of Dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/Governing Body but the same shall be Transferred to Another Charitable Trust/ Whose objects are similar to those of this Trust and which is registered U/s 12AA of Income Tax Act at the time of Transfer or shall be vested with the Government. 45. Investments of the fund of the Trust shall be in accordance with the provision of section 11 (5) read with section 13 (1) (d) of the Income Tax Act, 1961, as amended time to time. Investment and documents of title shall be made and be taken in the name of the Trust itself. 46. Notwithstanding any conditions laid down under any of the above clauses, any alienation of immovable property shall be carried out only with the approval of the concerned Commissioner of Income Tax. 47 Any Amendments to the Trust Deed/memorandum of Association/Dye Law will be Carries out only with the Prior Approval of the Commissioner of Income Tax having Jurisdiction. New Clauses 48 The Object/Activities of the Trust Shall be Carried out Only in India. 49. The Benefits of the Trust are Opening to All Irrespective of Caste, Religion, Creed, Sex etc. 50. The Trust will not function in the Nature of conducting any business Activity and not for purpose of Project. ----- Mohammed Hameed signed 18 ----- In witness whereof we have signed in this Deed of Trust in the presence of the under mentioned witnesses and the day month and year first above written at Malappuram Amsom Keezhimuri Desom and we have decided to Register this Deed in the office of the Sub-registrar Malappuram.
